



Memorandum of Understanding

between

Faculty of Science, Chiang Mai University

and

College of AI·SW Creative Convergence, Pai Chai University

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into on September 15, 2023 by and between:

The Faculty of Science, Chiang Mai University (hereinafter referred to as "FOS-CMU"), represented by Distinguished Professor Torranin Chairuangsri, Dean of Faculty of Science, Chiang Mai University, located at 239 Huaykaew Road A. Muang, Chiang Mai 50200, Thailand,

The College of AI·SW Creative Convergence, Pai Chai University (hereinafter referred to as "CASCC-PCU") represented by Prof. Hoekyung Jung, Dean of College of AI·SW Creative Convergence, Pai Chai University located at 155-40 Baejae-ro Seo-gu, Daejeon 35345, Korea.

FOS-CMU and CASCC-PCU agree to persue the followings in this MOU.

Article 1: Purpose and Scope of Cooperation

FOS-CMU and **CASCC-PCU** hereby agree to encourage and promote academic cooperation between their two respective parties. Subject to mutual consent, areas of cooperation and activities include:

- 1.1 Visits by faculty members and students from one university to the other for the purpose of engaging in research and other educational activities.
- 1.2 Admission of qualified students from one university to the other for the purpose of enrolling in undergraduate and graduate programs, or participating in research.
- 1.3 Exchange of academic information through seminars, academic conferences, and academic publications.

1.4. Promotion other academic activities to enhance the above mentioned goals.

Article 2.: Implementation & Funding

To implement the collaborative activities envisaged, representatives of FOS-CMU and CASCC-PCU may propose, negotiate and conclude specific agreements. Details, including financial arrangements, will be set out in said agreements. FOS-CMU and CASCC-PCU acknowledge that in the absence of any provision to the contrary in the specific agreement(s), all expenses of salary, travel, accommodation, living

and other related costs will be the responsibility of the visitor's home university.

Article 3: Confidentiality and Ownership of Intellectual Property

The two parties agree that in the event of research collaboration involving confidential information and leading to intellectual property rights, further agreement must be negotiated in each case in accordance

with the policies of the two parties.

Article 4: Amendment and Termination

4.1 This **MOU** becomes effective on the day it is signed and remains valid for five (5) years. Each party may terminate the **MOU** at anytime by notifying the other party of its intent to do so in writing at least

six (6) months in advance. Projects in progress at the time of **MOU** expiration or termination, as well as

obligations relating to confidentiality and intellectual property stated in Article 3, will remain unaffected.

4.2 Amendment or modification of the **MOU** content stated herewith can only occur after both parties discuss and create an appropriate supplementary agreement executed using the same formalities as this

MOU.

Article 5: Settlement of Disputes Law

The settlement of possible disputes between the parties concerning the interpretation and/or implementation of this MOU shall be negotiated in good faith to solve problems that arise.
