



Memorandum of Understanding

Between

Chiang Mai University

And

Andong National University

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into on July 1st 2024 (hereinafter referred to as "Effective Date") by and between:

Chiang Mai University (hereinafter referred to as "**CMU**"), represented by Prof. Dr. Pongruk Sribanditmongkol, President of Chiang Mai University, located at 239 Huaykeaw Road A. Muang, Chiang Mai 50200, Thailand,

And

Andong National University (hereinafter referred to as "ANU") represented by Prof. Dr. Tai-Joo Chung President of Andong National University located at 1375, Gyeongdong-ro(SongCheon-dong), Andong, Gyeongsangbuk-do, 36729, Republic of Korea

1. Purpose and Scope of Cooperation

CMU and **ANU** hereby agree to encourage and promote academic cooperation between their two respective parties. Subject to mutual consent, area of cooperation and activities include:

- 1.1 Visit by faculty members and students from one institute to the other for the purpose of engaging in research and other educational activities.
- 1.2 Exchange of academic information through seminars, academic conferences, and academic publications.
- 1.3 Promotion of other academic activities to enhance the above mentioned goals.

2. Implementation and Funding

To implement the collaborative activities envisaged, representatives of **CMU** and **ANU** may propose, negotiate and conclude specific agreements. Details, including financial agreements, will be set out in said agreements. **CMU** and **ANU** acknowledge that in the absence of any provision to the contrary in the specific agreement (s), all expense of salary, travel, accommodation, living and other related costs will be the responsibility of the visitor's home university.

3. Confidentially and Ownership of Intellectual Property

The two parties agree that in the event of the research collaboration involving confidential information and leading to intellectual property right, further agreement must be negotiated in each case in accordance with the policies of the two parties.

4. Amendment and Termination

- 4.1 This MOU becomes effective on the day it is signed and remains valid for five years. Each party may terminate the MOU at anytime by notifying the other party of its intent to do so in writing at least six months in advance. Projects in progress at the time of MOU expiration or termination, as well as obligations relating to confidentiality and intellectual property stated in Section 3, will remain unaffected.
- 4.2 Amendment or modification of the MOU content stated herewith can only occur after both parties discuss and create an appropriate supplementary agreement executed using the same formalities as this MOU.

5. Settlement of Disputes Law

The settlement of possible disputes between the parties concerning the interpretation and/or implementation of this MOU shall be negotiated in good faith to solve problems that arise.

This MOU is drawn up in English and both universities shall retain one original each.
